

"ESP LTD Snakebyte Giveaway x Metal Injection Giveaway Sweepstakes"
Official Rules

The "ESP LTD Snakebyte Giveaway x Metal Injection Giveaway Sweepstakes" (the "Sweepstakes") may only be entered by legal residents residing in the fifty (50) United States or the District of Columbia, excluding territories and possessions (the "Sweepstakes Territory"). One (1) Entry per person. All duplicate entries will be disregarded and Entrant may be disqualified. No automated entry devices and/or programs are permitted. The Sponsor is not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled Entries, which will be disqualified. Only fully completed Entries are eligible. Proof of submission will not be deemed to be proof of receipt by the Sponsor.

PRIZES.

One (1) Winner will receive one (1) -1 ESP LTD Snakebyte® electric guitar with carrying case

The approximate retail value ("ARV") of the Prize is One Thousand Four Hundred Ninety-Nine (\$1,499.00) Dollars. The ARV of the Prize represents the Sponsor's good faith determination. The Sponsor assigns no monetary value to any artist's autograph. This determination is final and binding and cannot be appealed. If the actual value of the Prize turns out to be less than the stated ARV, the difference will not be awarded in cash. The Prize is non-transferable.
